QUESTION 8

For example, if 'whta' is typed instead of 'what', then it gets corrected automatically when the spacebar is pressed after it. The AutoCorrect feature is also used to correct typographical errors, grammatical mistakes, and wrong capitalization. Common mistakes and their corrections are stored as AutoCorrect entries. Answer option D is incorrect. It is used to grant access to the users.

QUESTION 9

Sam works in an office and he is assigned with the task of preparing a document. He inserts a picture in the document. Now he wants to change the height and width of the picture. Which of the following groups will he choose to accomplish the task?

The Adjust group comprises options to set the contrast, brightness, color mode, etc. of the picture. It is found on the Format tab, which appears when a picture is selected.
